Legislature may convene a special legislative session to address State v. Obrero. Our office is working with Sen. Rhoads (Chair of Senate Judiciary) and Representative Nakashima (Chair of House Judiciary and Hawaiian Affairs) on draft of bill.

Attorneys are filing Obrero motions where it is appropriate. We are preparing a challenge of the applicability of HRPP Rule 12 (g).
